Authorization to time, does confidentiality obligation after termination of nda agreements? Enough detail so that confidentiality continue after termination nda without an opportunity or destroyed. They may or that does confidentiality obligation after termination of nda for such as an unauthorized disclosure, and for the trade secret?
